



**INVITATION TO BID FOR THE PROVISION OF JANITORIAL AND OTHER  
SUPPORT SERVICES FOR OWWA REGION 7 FOR THE PERIOD  
APRIL 16, 2024 – DECEMBER 31, 2024**

1. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, through the **FY 2024 National Expenditure Program (NEP)** intends to apply the sum of **One Million Nine Hundred Seventy-Five Thousand Four Hundred Ninety-Seven & 10/100 only (Php1,975,497.10)**, **PB-01-2024, Bidding for the Provision of Janitorial and Other Support Services for the period April 16, 2024 – December 31, 2024**, being the ABC to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The **OWWA** now invites bids for the above Procurement Project. Delivery of the Goods is required by *[insert the required initial delivery date or expected contract duration]*. Bidders should have completed, within **the last two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **OWWA BAC Secretariat and/or End-User**. The Bidding Documents can be viewed at the OWWA website at <https://bidding.owwa.gov.ph/>.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **11 March 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Two Thousand Pesos (Php2,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or by facsimile, or through electronic means. (See attached Guidelines on the Payment of Fees).
6. The **OWWA** will hold a Pre-Bid Conference on **11 March 2024, 02:00 p.m.** through at the **OWWA 7 Office, Lower Ground, Machay Building, Gorordo Avenue, Cebu City**, which shall be open to prospective bidders. (See attached Guidelines on the Conduct of Pre-Bid Conference).

7. Bids must be duly received by the BAC Secretariat through online or electronic submission on or before **25 March 2024, 11:00 a.m.** Late bids shall not be accepted. (See attached Guidelines on Bid Submission).
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **25 March 2024, 02:00 p.m.** at the **OWWA 7 Office, Lower Ground, Machay Building, Gorordo Avenue, Cebu City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **OWWA** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
