

## INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF MOTOR VEHICLE (5 UNITS OF PICK-UP TRUCK 4x2)

- 1. The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), through the General Appropriations Act RA 11639 (FY 2022 GAA) intends to apply the sum of Seven Million Five Hundred Thousand Pesos (Php 7,500,000.00) being the ABC to payments under the contract for Bidding for the Supply and Delivery of Motor Vehicle (Five (5) Units of Pick-Up Truck), PB-4A3-2023. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **OWWA** now invites bids for the above Procurement Project. Delivery of the Goods is required within Ninety (90) calendar days from the receipt of the Notice to Proceed (NTP). Bidders should have completed, within **the last three** (3) **years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **OWWA 4A BAC Secretariat** and/or End-User. The Bidding Documents can be viewed at the OWWA website at <a href="https://www.owwa.gov.ph">www.owwa.gov.ph</a> click the "Bids and Awards" icon.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 20, 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or by facsimile, or through electronic means. (See attached Guidelines on the Payment of Fees).
- 6. The **OWWA** will hold a Pre-Bid Conference on **22 November 2023, 10:00 a.m.** through face to face, video conferencing or webcasting *via ZOOM* which shall be open to prospective bidders. (See attached Guidelines on the Conduct of Pre-Bid Conference).
- 7. Bids must be duly received by the BAC Secretariat through online or electronic submission on or before **7 December 2023**, **11:00 a.m**. Late bids shall not be accepted. (See attached Guidelines on Bid Submission).
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

- 9. Bid opening shall be on **7 December 2023, 2:00 p.m.** via face to face and Zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **OWWA** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
